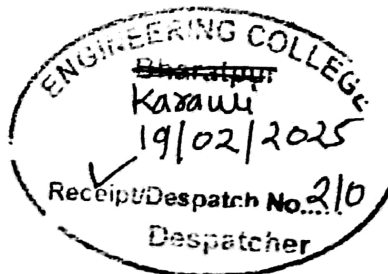
SN	Mandatory conditions abiding to the Institute

5	Under the provisions of Rajasthan Technical University, Kota, University representative shall be nominated in its governing body. Proceedings of all such meetings should be held in his presence.


